

### *November Incident*

The plaintiff claims that the defendant vandalized her office on November 3 2014. According to the plaintiff, she left her office at 11pm Monday, November 3<sup>rd</sup>. She returned at 11am on Tuesday November 4<sup>th</sup> to find that the art had been pulled off the walls, papers removed from her desk and glass broken. The plaintiff is not sure if the defendant destroyed the office on his own. She has reason to believe Research Assistant One may have been responsible. Despite multiple attempt to reach her, Research Assistant One did not respond to investigator's requests to meet.

When the plaintiff confronted the defendant about the incident he became immediately defensive. The plaintiff continued to push the issue, referencing a comment from the defendant's earlier tirade about made about 'destroying her shit so she can live like the animal she actually is'. Once she brought this up the defendant became 'extremely aggressive and agitated' and 'displayed threatening body language'. As the confrontation continued four of research assistants gathered and attempted to diffuse the situation. Once the defendant started throwing books and papers the plaintiff called security and the defendant was escorted off campus.
